#### 1. Opening of the Meeting

President, Horst Zemp calls the meeting 68th Annual meeting to order at 4:04 pm CST.

# 2. Approval of Minutes of 67<sup>rd</sup> Annual Meeting

#### **Auditor's Report 2024**

Beatrice presents the balance sheet of the last 3 years, which have been consistent. The rent went up at the storage unit because the Club pre-paid the rental fee cost, which was cut in half by moving to a smaller unit. Although the club lost money in 2023, it was made up in 2024.

### 6. **Membership**

Horst is asking the current members to invite friends to become members of the Swiss Club and not just attend events. Members need to pay up membership and PayPal offers an automatic (annual) renewal option.

Ruedi asks if folks can pay membership dues during any event and Milan said that they could. Renewal is typically in March. Lolita reports that the Swiss Club has a total 74 active memberships of which 57 are family and 17 individual. In 2024, the Swiss Club added 9 new memberships (6 families, 3 individual) and in 2025, 4 new memberships were added as of January 25.

#### 7. Membership dues

Milan moves motion to keep the membership cost unchanged, which are \$35 for an individual and \$40 for a family. Monique seconds the motion. The motion is unanimously approved.

#### 8. Honorary members

Horst is asking for nominations from the floor (the Honorary members do not pay any annual dues, only the event price). There are no nominations. Horst asks the past presidents to stand and be recognized. The past presidents include Peter Herdegg, Martin Lagler, Britta Renwick and Beatrice Weiss.

#### 9. Election of new Officers and Auditors

Peter Herdegg, Chair of the Election Committee, is taking over the Election Process of the Executive Board. Rafael served as Vice President in 2024 but cannot commit to assume the presidency in 2025 due to work and family commitments. Peter is thanking the Board for their work in 2024. The Board will go back to the structure prior to 2024, namely: Horst Zemp, President, Elke Sujdak, Vice-President, Milan Urban Jr., Treasurer, Sacha Urban, Secretary. Isabelle moves to approve the proposed executive board and Martin seconds the motion. The motion carries unanimously.

#### 10. Other Business

Horst is urging the member to get more people involved in the Swiss Club and for them to sign up as members, especially younger people. The Club is only as strong as its members. Milan reminds the members that if they volunteer for an event, they may attend it for free.

#### 11. Adjournment
